SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Move to fresh air. Keep at rest in a position comfortable for breathing. Get medical advice or attention if you feel unwell or are concerned.

Skin Contact

Avoid direct contact. Wear chemical protective clothing if necessary. Quickly and gently blot or brush away excess chemical. Immediately rinse with lukewarm, gently flowing water for 15-20 minutes. If skin irritation or a rash occurs, get medical advice or attention.

Avoid direct contact. Wear chemical protective gloves if necessary. Quickly and gently blot or brush chemical off the face. Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Take care not to rinse contaminated water into the unaffected eye or onto the face. Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Evacuate the area immediately. Isolate the hazard area. Keep out unnecessary and unprotected personnel. Do not touch damaged containers or spilled product unless wearing appropriate protective equipment. Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials.

Environmental Precautions

It is good practice to prevent releases into the environment. Do not allow into any sewer, on the ground or into any waterway. Minimize the use of water to prevent environmental contamination.

Methods and Materials for Containment and Cleaning Up

Cover the spill surface with the appropriate type of foam to reduce the release of vapour. Contain and soak up spill with absorbent that does not react with spilled product. Contaminated absorbent poses the same hazard as the spilled product. Knock down gas with fog or fine water spray. Do not direct water at spill or source. Remove or recover liquid using pumps or vacuum equipment. Flush spill area.

SECTION 7. HANDLING AND STORAGE

Precautions for Safe Handling

Obtain special instructions before use. Do not breathe in this product. Prevent all skin contact. Avoid repeated or prolonged skin contact. Do not get in eyes, on skin or on clothing. Only use where there is adequate ventilation. Avoid generating vapours or mists. Avoid release to the environment. Prevent accidental contact with incompatible chemicals.

Conditions for Safe Storage

Store in an area that is: well-ventilated, separate from incompatible materials (see Section 10: Stability and Reactivity). Have escape-type respiratory protective equipment readily available, in case of leaks or spills. Empty containers may contain hazardous residue. Store separately. Keep closed. Follow all precautions given on this safety data sheet. Comply with all applicable health and safety regulations, fire and building codes.
